

PROVISIONAL FEE STRUCTURE FOR THE SESSION 2025-26*DELHI PUBLIC SCHOOL VADODARA****Classes Pre Nursery to XII (For New Admission)**

Dear Applicant/ Parent

As you are already aware, **DPS VADODARA** is in the purview of the Gujarat Self-Financed Schools (Regulation of Fees) Act, 2017. As per the recommendation of Supreme Court and the Government of Gujarat, we have submitted our proposed fee structure for the ratification of Fee Regulatory Committee, Vadodara for further information and approval for the forthcoming Academic Year.

As an interim arrangement until clarity prevails in this matter (which is currently sub-judice) the following *provisional fee will be collected during the admission process of 2025-26.
